WHEREAS, the TARLAC STATE UNIVERSITY advertised the Invitation to Bid for the project Supply and Delivery of Desktop Computers for CAD, Rebid with an Approved Budget for the Contract (ABC) of ₱ 1,300,000.00 in the Philippine Government Electronic Procurement System (PhilGEPS) and in conspicuous places in Tarlac State University on October 31, 2023;

WHEREAS, in response to the Invitation to Bid, three (3) prospective bidders participated in the Pre-Bidding Conference held at Tarlac State University Business Center Audio Visual Room (TSU-BC AVR) on November 10, 2023;

WHEREAS, in the public bidding held at the TSU-BC AVR on November 21, 2023, at 2:00 P.M.:

- (a) one bidder, namely, Kaitliana Trading Corporation, tendered a bid for the aforementioned project,
- (b) the Bids and Awards Committee (BAC), with the assistance of the Technical Working Groups (TWGs), opened and evaluated the bid of the lone bidder and found it to be substantially complying with the eligibility, technical, and financial requirements for the project as prescribed in the Bidding Documents and was rated "passed",
- (c) the BAC resolved to declare Kaitliana Trading Corporation, as the bidder with the Single Calculated Bid with the amount of 1,300,000.00,
- (d) the BAC directed the TWGs to proceed with the Post-Qualification Evaluation of the and Single Calculated Bid;

WHEREAS, in the Post-Qualification Evaluation Conference held via Zoom on January 4, 2024:

- (a) the TWG for Financial and Legal Aspects reported that the Single Calculated Bid was responsive to the legal and financial requirements for the project as prescribed in the Bidding Documents,
- (b) the TWG for Technical Aspect reported that the item offered by the Single Calculated Bid is assembled,
- (c) the BAC deliberated the TWG reports, and unanimously agreed to declare the bid of Kaitliana Trading Corporation as "responsive";

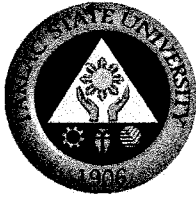

WHEREAS, the TARLAC STATE UNIVERSITY advertised the Invitation to Bid for the project Supply and Delivery of Desktop Computers for CAD, Rebid with an Approved Budget for the Contract (ABC) of ₱ 1,300,000.00 in the Philippine Government Electronic Procurement System (PhilGEPS) and in conspicuous places in Tarlac State University on October 31, 2023;

WHEREAS, in response to the Invitation to Bid, three (3) prospective bidders participated in the Pre-Bidding Conference held at Tarlac State University Business Center Audio Visual Room (TSU-BC AVR) and webcasted via Zoom on November 10, 2023;

WHEREAS, in the public bidding held at the TSU-BC AVR on November 21, 2023, at 2:00 P.M., one (1) bidder, namely, Kaitliana Trading Corporation participated and tendered a bid for the aforementioned project,

WHEREAS, the Bids and Awards Committee (BAC), with the assistance of the Technical Working Groups (TWGs), opened and checked the first envelope contained in the bid submitted by the lone bidder, using the non-discretionary "pass/fail" criterion, and found that the first envelope of Kaitliana Trading Corporation contained all the required documents and was rated "passed".
