

The Soya Milk Extractor was initially donated by the Local Government of Pura, Tarlac in support of their livelihood program prompting the extension service that has necessitated the assistance of the faculty experts in evaluating the optimal functionality and safety of the equipment.

Prof. Sibal and Prof. Sarabia conducted a comprehensive observation and analysis of the machine's performance in operation, meticulously examining each part and its mechanism. Their inspection also extended to the

platform supporting the equipment, the installed power outlet for the machine's

personal hygiene kits, clothing, books, and toys, graciously contributed by benefactors and various donors.



CPAG ENHANCES SAN JOSE'S ECO-TOURISM, **CONDUCTS STRATEGIC PLANNING SEMINAR**

To augment strategic eco-tourism management for local government officials in the Municipality of San Jose, the College of Public Administration and Governance (CPAG), in conjunction with Dr. Myrna Q. Mallari, the former president of Tarlac State University (TSU), and her Doctor of Public Administration (DPA) students, held a strategic planning seminar-workshop on August 3, 2023, at the San Jose, Tarlac municipal hall.

The extension activity aims to empower LGU-San Jose officials in formulating a strategic plan for responsible and sustainable eco-tourism. Balancing environmental preservation, cultural sensitivity, and community well-being is crucial. DPA students, acting as resource speakers, shared insights and strategic planning expertise, based on their observations and proposed framework developed during a preliminary visit to San Jose's ecological sites.

In the workshop, a thorough SWOC (Strengths, Weaknesses, Opportunities, and Challenges) analysis was conducted where the participants actively shared perspectives and concerns about their municipality. Notable strengths include the

municipality's pivotal role as a watershed supplying 80% of the province's water and a 5,000-hectare protected area with nine **Indigenous Peoples** communities, overseen by a proficiently managed Protected Area Management Board (PAMB).

However, due to some conservatism, the municipality lacks a concrete tourism policy and hesitates to promote its own attributes which was reflected in

the absence of support for IPs and a declining agricultural community pose challenges.

Meanwhile, actionable points include pursuing national programs for ecological policies, establishing a community college, coordinating with the NCIP for the registration of unregistered IP communities, and adopting solar-powered vehicles to mitigate emissions.

Furthermore, challenges highlighted encompass the formulation of include formulating environmental and ecological policies, responsibly selling lands within IPs' ancestral domains, and conserving the mountain ecosystem while prudently utilizing available

This initiative garnered positive feedback from the representatives of the





CCJE EMPOWERS CAMILEÑOS WITH KATARUNGANG **PAMBARANGAY LAW SEMINAR**

C triving to enhance community-• based conflict resolution and promote peace and harmony at the grassroots level, the College of Criminal Justice Education (CCJE) organized a seminar on the Katarungang Pambarangay Law as a component of the ongoing Project LIGTASS or the Localized Innovation Geared Towards Addressing Security and Safety in Barangay Poblacion H, Camiling,

Tarlac, on September 8, 2023.

CCJE Faculty Experts Atty.
Theodore M. Timpac, Dr. Jayson R. Felix, and Ms. Marie Fe F. Buscayno, shared their extensive knowledge on Katarungan Pambarangay Law during the seminar, highlighting its crucial role in resolving disputes and conflicts within local communities.

The Katarungang Pambarangay Law (PD 1508, Sections 1-19) is cornerstone of community-based conflict resolution in the Philippines. Atty. Theodore M. Timpac, discussed the PD 1508, Sections 1-6, emphasizing its foundational principles. He stressed its role in fostering peace at the barangay level through mediation and reconciliation, urging parties to seek amicable resolutions and avoid costly

and time consuming litigation. Meanwhile, Dr. Jayson R. Felix delved into PD 1508 Sections 7-12, emphasizing the important role of the Lupong Tagapamayapa in facilitating resolutions. He highlighted the importance of welltrained barangay officials and their mediation skills in ensuring the efficacy of the Katarungang Pambarangay process, underscoring how the law fosters both dispute resolution and community unity.

The seminar

concluded with Ms. Marie Fe F. Buscayno discussing PD 1508 Sections 13-19. She clarified the legal implications when parties refuse to participate in the Katarungang Pambarangay proceedings, emphasizing compliance with the law and the barangay justice system. Her overview emphasized that the Katarungang Pambarangay Law is a vital legal framework deserving respect and recognition.

Consequently upon significant discussions on the aforementioned law, a resident from Barangay Poblacion H consulted Atty. Timpac about her son's legal matter, illustrating the immediate applicability of the seminar's knowledge.

"Salamat po Atty. Timpac dahil sa inyo po naliwanagan ako tungkol sa kaso ng aking anak, nagkaroon po ulit ako ng pag-asa na makakamit pa ang hustisya sa pagkamatay ng aking anak" she expressed her gratitude. The CCJE seminar substantially

contributed to the attainment of Sustainable Development Goal 16, emphasizing the crucial role of community-based legal frameworks in advancing global objectives for Peace, Justice, and Strong Institutions.

CCS CAPACITATES GERONA LGU ON COMPUTER MAINTENANCE, TROUBLESHOOTING ESSENTIALS



With the aim of enhancing technological proficiency of employees, the Advancing Technology and Advancing Governance Extension Team from the College of Computer Studies, led by Dr. Marlon V. Gamido, extended expert service for the Local Government Unit (LGU) of Gerona's Human Resources Development Office and Management Information Systems Office through a one-day training on Basic Computer Maintenance and Troubleshooting on July 20, 2023.

The training aimed at equipping LGU Gerona staff with essential knowledge to improve their computer literacy. problem-solving capabilities and skills for routine computer maintenance and basic software and hardware issue

The comprehensive training covered key aspects of computer maintenance and troubleshooting, introducing participants to the significance of these practices and providing an overview of common computer issues. Additionally,Hon. Eloy C. Eclar, mayor of Gerona, encouraged participants to share gained knowledge with their fellow colleagues, enhancing the LGU's services.

Meanwhile, Dr. Heidilyn V. Gamido, an expert service provider from CCS, assisted by Prof. Valarie D. Simbol, led the Computer Hardware Overview session in the comprehensive training, covering key aspects of computer maintenance, troubleshooting, and introducing participants to their significance and common issues.



for computer equipment.

Moreover, the afternoon sessions focused on Software Maintenance and Troubleshooting Techniques. Mr. Virtudazo assisted by Prof. Jerome Legaspi, further identified the common computer problems and honed their troubleshooting skills for software and hardware issues.

For LGU Gerona and similar organizations, network connectivity is crucial. Dr. Edjie Delos Reyes and Dr. Marlon V. Gámido led a session on Troubleshooting Network Connections, empowering participants to identify and resolve both wired and wireless connectivity issues. The training also addressed computer security and virus protection, providing insight into safeguarding systems from malware and demonstrating basic security

A training highlight was the hands-on Practical Exercises and Skills Assessment. Participants applied new knowledge and skills in computer maintenance and troubleshooting

scenarios, deepening their understanding of covered concepts.

As part of the Gender and Development Training program at Aranguren Integrated School-High School Department, the College of Public Administration and Governance (CPAG) conducted lectures and workshops on July 18, 2023, focusing on RA No. 11313 and RA No. 6713.

Republic Act No. 11313, commonly known as the Safe Spaces Act, is a crucial legislation designed to prevent genderbased sexual harassment in public spaces, workplaces, educational institutions, and digital platforms. Enacted on April 17, 2019, the law aims to foster a culture of and inclusivity,

in our society to uphold the welfare and progress of our nation."

Further, Dr. Caoleng underscored the importance of the eight norms of conduct for public officials and employees, emphasizing the priority of public interests, professionalism, fairness, political neutrality, accessibility, nationalism, democratic principles, and modest lifestyles.

Dr. Fermin discussed prohibited acts in RA 6713, emphasizing avoiding gifts, influence peddling, nepotism, and conflicts of interest.

Dr. Caoleng initiated the conversation by elaborating on the core principle that "public office is a public trust," outlined in Article XI, Section 1 of the Philippine Constitution and reiterated in RA 6713. He stressed that public employees should prioritize the people's welfare over personal interests, advocating for ethical conduct and government transparency. Dr. Caoleng highlighted, "It is expected that this principle remains a fundamental value

he added, underscoring the importance of upholding duties and responsibilities.

Moreover, Dr. Estrada and Ms. Francisco jointly discussed the Safe Spaces Act, RA 11313, designed to combat genderbased sexual harassment in physical and virtual public spaces. They outlined the law's scope, harassment definition, and channels for confidentially reporting incidents, emphasizing its goal to foster safe environments and deter harassment. Offenders risk fines, community service, and imprisonment if found guilty, with the law stressing the significance of education

recognizing these as fundamental to societal progress and cohesion. Emphasizing the importance of trust, inclusivity, transparency, and sustainable development, the activity aimed to strengthen our nations foundation, empowering it to navigate

evolving challenges.


